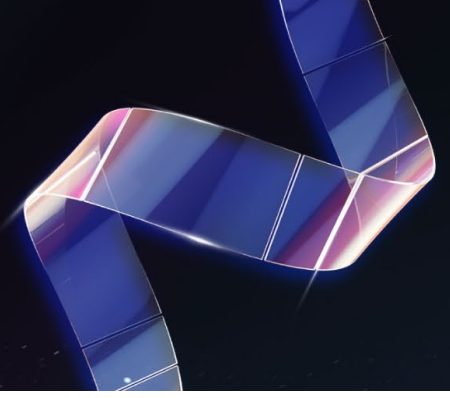




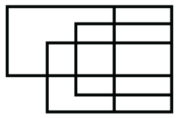
## **Enhanced Production Funding for Female Talent**

GUIDANCE NOTE



### **Guidelines**

- This production funding applies only to projects which qualify for Fís Éireann/Screen Ireland (Screen Ireland) [Fiction Irish Production](#) (live action and animated feature films) and [Documentary Production](#) funding scheme (feature length cinematic documentary films).
- This production funding is available for **Irish female talent only (resident or born in Ireland)**.
- This production funding will be made available in addition to the amount/limits currently available as stated in the Screen Ireland's [Production Funding Guidelines](#).
- For [Fiction Irish Production](#) the maximum amount of enhanced production funding available to a project is €100,000 as follows:
  - €50,000 will be available to a project with a **female Writer** attached where the Writer is the originating and lead Writer. €25,000 will be available where a female Writer is part of the originating co-writing team. A maximum of €50,000 is available for a project with multiple female Writers. *Note this does not apply where a female Writer(s) is not the originating/lead Writer(s).*
  - €50,000 will be available to a project with a **female Director** attached. €25,000 will be available where a female Director is part of a mixed gender co-directing team. A maximum of €50,000 is available for a project with multiple female Directors.
  - €100,000 will be available to a project with a **female Writer/Director** attached.
- For [Documentary Production](#) the maximum amount of enhanced production funding available to a project is €25,000 as follows:
  - €25,000 will be available to a project with a female Director attached. €12,500 will be available where a female Director is part of a mixed gender co-directing team. A maximum of €25,000 is available for a project with multiple female Directors.
- This funding will be available until further notice.



- This funding will not be applied retrospectively. Projects already in receipt of a quantified offer of production finance from Screen Ireland are not eligible. Projects in receipt of an unquantified offer of production finance from Screen Ireland are eligible from 29th September 2017.

## **Additional Notes**

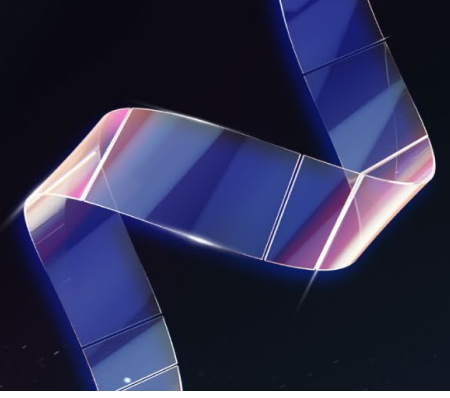
- As with all applications received by Screen Ireland, each submission will be assessed utilising the Screen Ireland's general [Principles and Criteria](#) with particular attention paid to the editorial strength of the screenplay, track record of the creative team, market appetite, feasibility of the production budget and finance plan as well as readiness for production.
- The total Screen Ireland funding awarded (including this enhanced support) cannot exceed the Screen Ireland's state sanctioned [Regulations and Limits](#) (in most cases 65% of the total budget). The total Screen Ireland funding awarded must comply with the Screen Ireland's's Admissible Irish Expenditure guidelines.

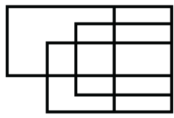


### **Treoirlínte**

- Baineann an maoiniú léiriúcháin seo le tionscadail a cháilfionn don scéim mhaoinithe Ficsean: Léiriú Éireannach amháin de chuid bhFís Éireann/Screen Ireland (FÉ/SI) (príomhscannáin bheochana agus bheognímh);
- Tá an maoiniú léiriúcháin seo ar fáil do mhná Éireannacha amháin (atá ina gcónaí in Éirinn nó a rugadh in Éirinn);
- Cuirfear an maoiniú léiriúcháin seo ar fáil sa bhreis ar an mhéid/na teorainn atá ar fáil faoi láthair mar a leagtar amach i dTreoirlínte um Maoiniú Léiriúcháin de chuid FÉ/SI.
- Is é €100,000 an uasmhéid atá ar fáil mar mhaoiniú léiriúcháin breisithe do thionscadal, mar seo a leanas:
  - Beidh €50,000 ar fáil do thionscadal a bhfuil ban-Scríbhneoir luaite leis, nuair is í an Scríbhneoir an príomh-Scríbhneoir agus an Scríbhneoir bunaidh. Beidh €25,000 ar fáil nuair atá ban-Scríbhneoir mar chuid den fhoireann chomhscríbhneoireachta bhunaidh. Beidh uasmhéid de €50,000 ar fáil nuair atá ban-Scríbhneoirí éagsúla ann. Coimhead nach mbeidh seo i bhfeidhm nuair nach ban-Scríbhneoir(i) í(iad) an príomh-Scríbhneoir/Scríbhneoir bunaidh;
  - Beidh €50,000 ar fáil do thionscadal a bhfuil ban-Stiúrthóir luaite leis. Beidh €25,000 ar fáil nuair atá ban-Stiúrthóir mar bhall d'fhoireann chomhstíúrthóireachta mheasctha. Beidh suas le €50,000 ar fáil do thionscadail a bhfuil ban-Stiúrthóirí éagsúla ann;
  - Beidh €100,000 ar fáil do thionscadal a bhfuil ban-Scríbhneoir/Stiúrthóir luaite leis;

### **Scannán Faisnéise**

- Is é €25,000 an uasmhéid atá ar fáil mar mhaoiniú léiriúcháin breisithe do thionscadal, mar seo a leanas:
  - Beidh €25,000 ar fáil do thionscadal a bhfuil ban-Stiúrthóir luaite leis. Beidh €12,500 ar fáil nuair atá ban-Stiúrthóir mar bhall d'fhoireann chomhstíúrthóireachta mheasctha. Beidh suas le €25,000 ar fáil do thionscadail a bhfuil ban-Stiúrthóirí éagsúla ann;
- Beidh an maoiniú seo ar fáil ón 29ú Meán Fómhair 2017 (an chéad spriocdháta eile do mhaoiniú léiriúcháin FÉ/SI) go dtí go bhfuil fógra breise tugtha;
- Ní chuirfear an maoiniú seo in áit go siarghabhálach. Tá tionscadail a bhfuil tairiscint de mhaoiniú léiriúcháin le luach ainmnithe faighte acu ó FÉ/SI cheana neamh-incháilithe. Tá tionscadail a bhfuil tairiscint de mhaoiniú léiriúcháin gan luach ainmnithe faighte acu ó FÉ/SI incháilithe ón 29ú Meán Fómhair 2017



## Nótaí Breise

- Mar atá an cás le gach iarratas a fhaigheann FÉ/SI, déanfar measúnú ar gach iarratas ag baint leasa as na Prionsabail agus Critéir ghinearálta de chuid FÉ/SI, le béim ar leith ar láidreacht eagarthóireachta na scrípte, cúlra na foirne chruthaitheacha, dúil an mhargaidh, féidearthacht an bhuiséad léiriúcháin agus an phlean airgeadais, chomh maith le hullmhacht an tionscadail le dul i mbun léiriúcháin.
- Ní féidir leis an mhaoiniú iomlán a bhronnann FÉ/SI (an tacaíocht bhreistithe seo san áireamh) a bheith níos mó ná an méid a leagtar síos sna Rialacháin agus Teorainneacha stáit-faomhaithe de chuid FÉ/SI (65% den bhuiséad iomlán i bhformhor na gcásanna). Ba chóir go gcloífidh an maoiniú iomlán a bhronnann FÉ/SI leis na treoirlínte maidir le Caiteachas Ceadaithe Éireannach.

*Moltar d'iarratasóirí súil a chaitheamh ar an eolas ar fad faoi Cláir Mhaoinithe ar shuíomh gréasáin FÉ/SI sula dhéantar iarratas, agus ar an chóras iarratais ginearálta agus ar na spriocdhátaí le teacht.*
